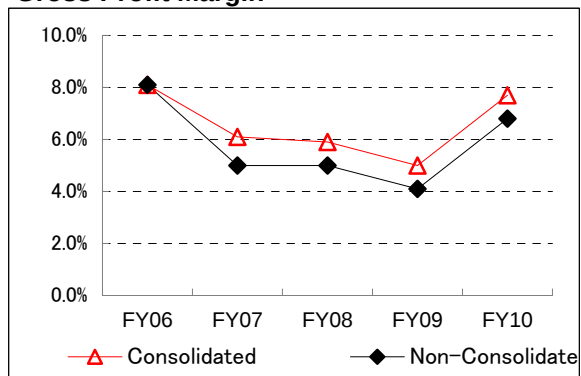
Gross Profit



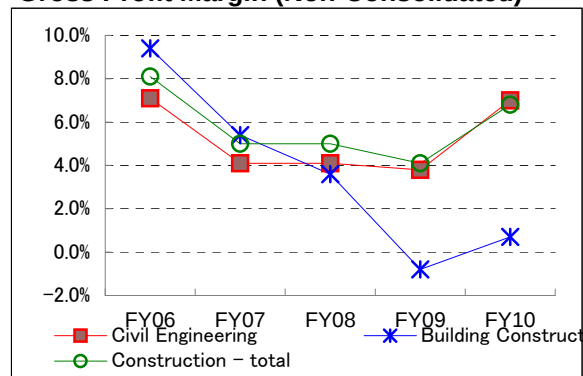

Gross Profit Margin

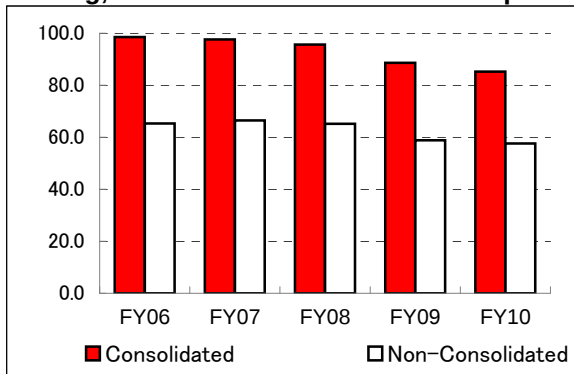
