Decline in domestic public works is primarily due to drop in contract awards from local governmental agencies both in civil and building segments. On the other hand, increase in domestic private works is due to rise in building works both in manufacturing and non-manufacturing sectors.

Contract awards for real estate and others have made a considerable increase against the same period of last year due to the closing of the sales agreement for a large-scale real estate property.
